## About SyCom



SyCom is an umbrella organisation of independent membership bodies and stakeholders across the security industry, providing a forum for discussion and co-operation in the common interest and in the promotion of professionalism, good practice and information sharing to enhance security across the UK.

The Estimated Annual Turnover of UK Regulated Security Industry is £4.44 billion\* with Security Commonwealth (SyCom) representing companies responsible for over £3 billion – almost three quarters of that turnover.

In people terms, SyCom reach is to over 370,500 licensed security officers in the United Kingdom and also a large number of unlicensed professional security officers - an important group of directly employed staff.

Membership includes the major security membership organisations in the UK, such as Institute of Workplace and Facilities Management (IWFM), the Security Institute, the Cross-sector Security and Safety Communications (CSSC), the British Security Industry Association (BSIA), The City Security Council (CSC), the City of London Crime Prevention Association (CoLCPA) and the Night Time Industry Association (NTIA), and stakeholders such as NSI. Each of these organisations is represented on SyCom's Special Interest Steering Group.
